**4. FIRST AID MEASURES**

## 6. ACCIDENTAL RELEASE MEASURES

**Spill Clean Up.** Eliminate all ignition sources. Put on appropriate personal protective equipment (see section 8). Absorb with an inert material and place in an appropriate waste disposal container. Finish cleaning by spreading water on the contaminated surface and dispose of according to local and regional authority requirements.

## 7. HANDLING AND STORAGE

**Handling.** Put on appropriate personal protective equipment (see Section 8). Do not get in eyes or on skin or clothing. Do not breathe vapor or mist. Do not ingest. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Do not reuse container. Wash thoroughly after handling.

**Storage.** Store between the following temperatures: 4.44 to 48.9°C (40 to 120°F). Store in accordance with local regulations. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see section 10) and food and drink. Separate from acids. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers. Use appropriate containment to avoid environmental contamination.
